1. Payment of account in full is due and payable on the 10th day of the month immediately following the month in which related invoice(s) was/were issued.
2. A service charge of 2% per month will be charged on any balance over 30 days past due.
3. Permission from SEMCO TIRE LTD. Must be obtained before returning any goods for credit. All special order items that are returned will be subject to manufacturers restocking charge.
4. In connection with any application for credit, I/we authorize and consent to SEMCO TIRE LTD. conducting and or causing to be conducted, a credit investigation(s) and exchange(s) of credit information about the/me/us/ the entity that I am acting on behalf of.
5. In the event of default of payment on this account, I/we agree to be responsible for all collection costs incurred by SEMCO TIRE LTD. Including without limitation all legal fees & disbursements on a solicitor and his own client full indemnity basis.
6. I/we warrant that all information contained herein to be correct and that I/we am/are authorized to execute this application on behalf of the business named herein, if applicable.
7. Any cheques returned for any reason are subject to a service charge of \$20.00 per occurrence.
8. SEMCO TIRE LTD. reserves the right to suspend or revoke the customers credit privileges at anytime without notice to the applicant.
9. The customer will advise SEMCO TIRE LTD. In writing of any changes in its trade name and/or legal name and/or address and/or any change in ownership at least 10 business days prior to such change(s).
10. Failure to comply with the above terms and conditions will result in immediate cancellation of all credit privileges.
11. SEMCO TIRE LTD. Hereby reserves title to the product(s) described herein until such time as SEMCO TIRE LTD. Receives payment in full therefore.

Possession of the goods and chattels described herein is not to be considered evidence of ownership, but is expressly agreed that the title to all said property is to remain in the company that provided same to the customer until the full amount of the purchase price, interest, any note or security given therefore or any judgment obtained thereof and any other monies owing by the customer to SEMCO TIRE LTD. Is paid in full. In the case of default in payment or in case of removal of said goods, or any part thereof, without the express written consent of SEMCO TIRE LTD. Or in the event the customer shall mortgage or part with the said possession of the said property voluntarily or involuntarily without the prior written consent of SEMCO TIRE LTD. Shall have the right to immediately to resume possession of same wherever it may be found and remove it with or without process of law.
